RESOLUTION NO. 2026-002

WALLACE COMMUNITY SERVICE DISTRICT

WHEREAS, an election will be held within the Wallace Community Service District within Calaveras County on November 3, 2026, for the purpose of electing Governing Board Members; and

WHEREAS, Election Code §10403 requires jurisdictions to file with the Board of Supervisors, and the County Clerk, a resolution requesting consolidation with said election.

THEREFORE, BE IT RESOLVED, that the Wallace Community Services District requests the Board of Supervisors of Calaveras County to consolidate the District Election with the election to be held on November 3, 2026.
